- 4.1 The Monitoring Committee members approved the rejection of administratively incompliant and ineligible Application of project S.L.O.G.A. that was submitted in the frame of the 1st Deadline of the Open Call for proposals for Small-scale projects.
- 4.2 The Monitoring Committee members agreed that the rejected project can be informed about the results of the administrative and eligibility check prior to the approval of final Minutes of the 6th MC meeting.
- 4.3 The Monitoring Committee members were informed about the received Applications and assessment process within the 1st Deadline of the Open Call for Proposals for Small-scale projects.

CONCLUSIONS 5:

5.1 The Monitoring Committee members decided to approve 73 Small-scale projects, reaching 76 points or more (in the max amount of 1.433.939,20 EUR ERDF). The Lead Partners will be notified about reserve list placement. The reserve list will be published on the web page of the programme.

- 5.1.1 The Monitoring Committee members approved the projects under the conditions stated in the Summary appraisal grids. MC approved project COOFRI with additional conditions:
- Partnership has to introduce an additional Slovenian partner from NUTS 3 directly bordering Croatia. The impact of the additional project partner activities should be focused on NUTS 3 regions directly bordering Croatia. Partnership has to ensure that in Slovenia the impact of the project should be focused on regions (NUTS 3) that are directly bordering Croatia.
- Project budget has to stay in the frame of the current requested ERDF funds and has to be aligned accordingly and prove balanced budget.

MC gave a mandate to the Joint Secretariat to check the fulfilment of conditions and any other clarifications needed with the Lead partners (in the frame of the face-to-face meetings). The JS can send decision letters to the Lead partners immediately (before the approval of the MC meeting minutes) and start with the procedure for signing the ERDF Subsidy contracts. The letter of approval and the letter of placement on the reserve list can be sent to the LP before the approval of MC meeting minutes.

- 5.1.2 The Monitoring Committee members decided that the opinion on State aid (whether the activities in the submitted project application are state aid/de minimis relevant) is provided before signing the ERDF Subsidy Contract.
- 5.2 The Monitoring Committee members rejected 74 projects due to not reaching the threshold of 60 points in the quality assessment.
