DECISIONS 5:

5.1 The Monitoring Committee members decided to approve 6 projects for Priority 2 (in the max amount of 7.787.693,26 EUR ERDF). The approved projects are the following: Šavrinke, InterWine, Living Castles 2.0, ENVIRO, Zlatarske avanture, Terra Gothica Incognita.

5.1.1 The Monitoring Committee members approved the projects under the conditions stated in the Summary appraisal grids and co-formed on the Monitoring Committee meeting as well as conditions set by the Monitoring Committee. MC gave a mandate to the Joint Secretariat to check the fulfilment of conditions and any other clarifications needed with the Lead Partners (in the frame of the face-to-face meetings). The Joint Secretariat can send decision letters to the Lead Partners immediately (before the approval of the MC meeting minutes) and start with the procedure for signing the ERDF Subsidy Contracts. The letter of approval can be sent to the Lead Partners after the MC meeting.

5.1.2 The Monitoring Committee members decided that the opinion on State aid (whether the activities in the submitted project application are state aid/de minimis relevant) is provided before signing the ERDF Subsidy Contract.

5.2 The Monitoring Committee members rejected 43 projects in the frame of Priority 2. The rejected projects are the following: GLAGOLJICA, MALA BARKA green, MINE STORY, CampINCulture, EWN 4.0, COULTOURSEA, CBC Chef, Kaštelir II, CULTURE MAKERS, WineTourStory, SANTANA, 4SUSTAINABLETOURISM, HERITAGE4US, Tourism4Rural, MISTERION II, FILM FRIENDLY ISTRIA, KoloPOTec, TASTE, SKILLS+, KULTUREVITA, ARTTOUR, FLOWS, CULTRA, DESTW(f)OOD, KULT(D)ESIGN, SEM-TAM, SMART SEA STARS, Zelena Kupa/Kolpa, HD-Cert, Learned sustainability, EkoLuk, Albus trail, ICIE, BEeForest, TransHealth, CHESST, Futourism 5.0, ExplorAR, BEESEE, MAGIC, D-STAR TUR, TOURISM PRO-FUTURE, GENYGreen.

5.2.1 The Monitoring Committee members rejected the projects due to not reaching the threshold of 70 points in the quality assessment. The Joint Secretariat can send the letter of rejection to the Lead partners before the approval of the MC meeting minutes.
