

AMENDMENTS

to the documentation relating to the Open Call for Proposals for standard projects for Priority 1 and 3 (specific objective 6.2) in the frame of the Interreg Programme Slovenia-Croatia 2021-2027 (Reference number: 4300-2/2023-MKRR) published on 24 March 2023

In line with Point 17 (Amendments to the Open Call for Proposals) of the Open Call for Proposals for standard projects for Priority 1 and 3 (specific objective 6.2) in the frame of the Interreg Programme Slovenia-Croatia 2021-2027 the original text of the documentation relating to the Open Calls for Proposals in the Slovenian, Croatian and English versions shall be amended as set forth below. Applicants are obliged to respect only the amendments published on the dedicated programme website www.si-hr.eu.
